APPLICATION FOR CERTIFICATE OF NO IMPEDIMENT TO MARRIAGE

Jamaican nationals entering a marriage with a foreign national may require a Certificate of No Impediment to Marriage, issued by the Ministry of Justice, Jamaica. The Embassy of Jamaica in Berlin facilitates the process by transmitting the documents to the Ministry of Justice. The Embassy has been advised that the processing time is approximately 3 weeks.

The procedure is a follows:

1. The applicant should write a Letter of Request addressed to: Permanent Secretary, Ministry of Justice, 2 Oxford Road, Kingston 5

The letter should provide the following information:

- Your Full Name of the Applicant
- Your Date and Place of Birth
- Your usual Place of Residence (Address) or last two places of Residence in Jamaica
- The Name, Nationality and Address of the Person you intend to marry
- The Names and Addresses of Two (2) Jamaican Residents who are willing to provide References on your behalf.
- 2. The letter should be submitted to the Ministry, along with the following:
- Original certified Birth Certificate (or a certified Copy)
- Your Jamaican Passport (or a certified copy of the first five (5) pages)
- A personal AFFIDAVIT [copy attached]
- The two (2) AFFIDAVITS [copy attached]¹ duly completed by the two (2) persons providing References, signed in the presence of a Justice of the Peace
- Two (2) certified Passport Photographs
- If you were previously married, a certified copy of your Marriage Certificate, Decree Absolute if you are divorced or a Death Certificate if you are widowed
- A fee of Euros 20 in cheque, made payable to: Embassy of Jamaica, Berlin to cover administrative and transmission costs.

PLEASE NOTE THAT ALL ACCOMPANYING DOCUMENTS MUST BE CERTIFIED BY A JUSTICE OF THE PEACE, A NOTARY PUBLIC, COMMISSIONER OF OATHS OR A JAMAICAN CONSULAR OFFICER.
